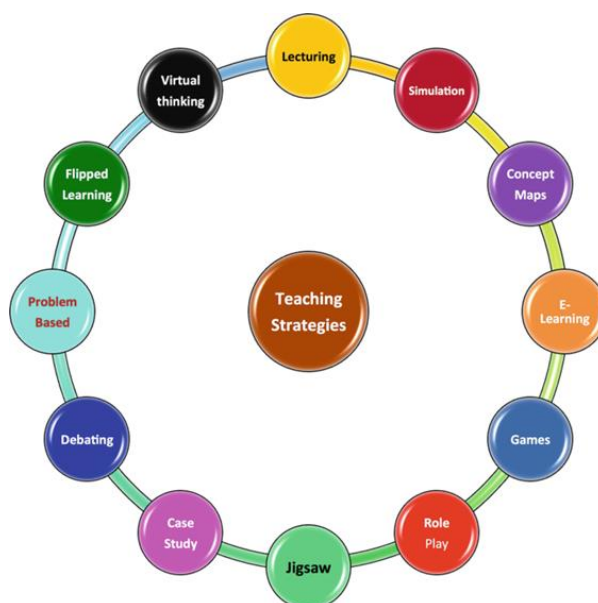


Figure 1: The Art of Teaching Nurses

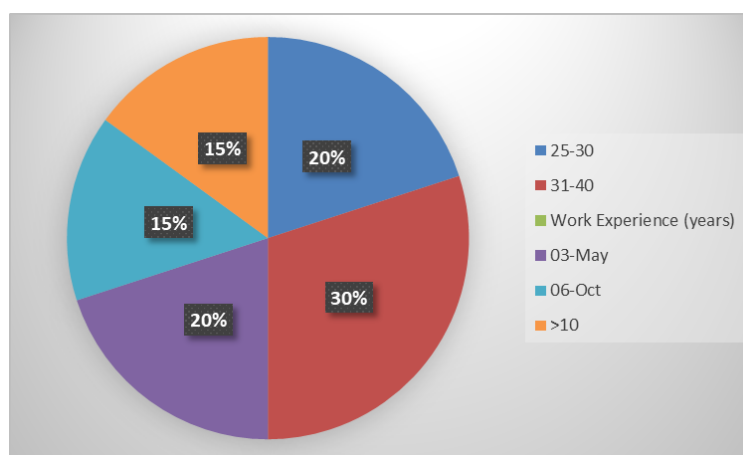


Figure 2: Demographic Profile of Survey

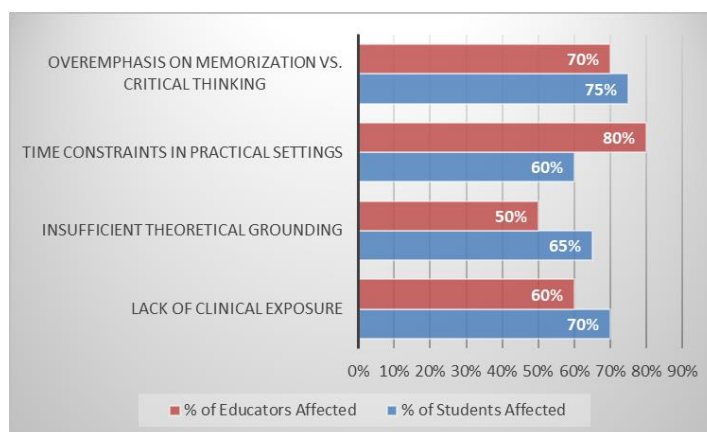


Figure 3: Challenges in Teaching and Learning the Nursing Process

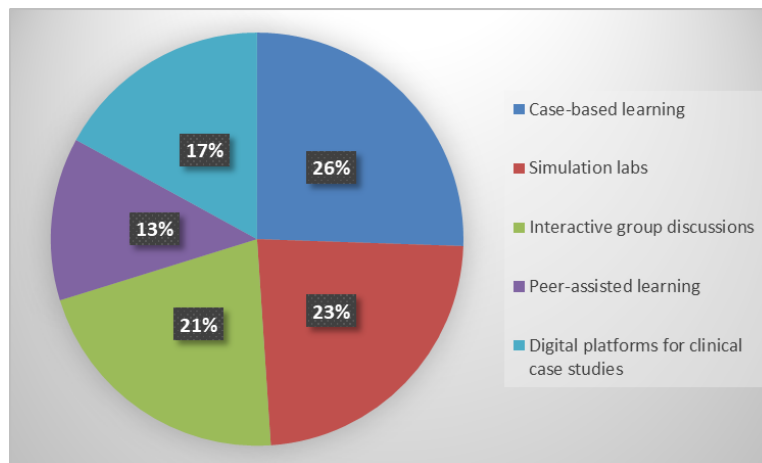


Figure 4: Strategies Identified by Educators
